ORDER

Whereas in terms of Section 14(1) of the NCTE Act, 1993 Sri Balaji Educational Charitable and Cultural Trust, No. 102/26, Salem Main Road, Chinnasalem, Kalla Kurichi Taluk, Villupuram, Tamilnadu had submitted an application to the Southern Regional Committee of NCTE for grant of recognition to Sri Balaji College of Education, Sri Balaji Educational Charitable and Cultural Trust, Salem Main Road, Poondi Village, Ammayagaram Post, Kallakurichi Taluk, Villupuram District, Tamilnadu for B.Ed Course.

And whereas, the Southern Regional Committee, after considering the report of the visiting team as well as other relevant materials granted recognition for offering B.Ed course with an annual intake of 100 students on 25.06.2009 with the condition the institution shall shift to its own premises/building within three years from the date of recognition.

And whereas, the institution vide its letter dated 01.11.2010 submitted its proposal for shifting of premises along with Rs.40,000/- towards inspection fee. The committee in its 198th Meeting held on 24th-26th November 2010 considered the written reply and other documents submitted by the institution and decided to cause inspection at the new premises Under Section 17 of NCTE Act. The institution is directed to submit the documents within 30 days of the receipt of the notice, duly filled in Questionnaire along with all the necessary documents for land, building approval and completion certificate from a competent Govt. Engineer FDRs for Rs. 5 lakhs and 3 lakhs, and other relevant documents. Accordingly a letter was issued to the institution on 06.01.2011.

And whereas, the inspection of the institution was fixed between 14th-19th February 2011 and was intimated to the institution on 07.02.2011. Accordingly inspection of the institution for shifting of premises was conducted on 14.02.2011.

And whereas, the SRC in its 202nd meeting held on 14th-15th March 2011 considered the VT Report, VCD and all the relevant documentary evidences and it was decided to serve Show Cause Notice under Section 17 of NCTE Act. Accordingly show cause notice was issued to the institution on 15.04.2011. The institution submitted its reply on 04.05.2011.

And whereas, the SRC in its 205th meeting held on 18th -19th May, 2011 considered the reply of the institution dt. 04.05.2011 to the show cause notice and it was decided to serve Final Show cause Notice under Section 17 of NCTE Act for the following. Accordingly, final show cause notice was issued to the institution on 27.06.2011. The institution in its reply submitted on 28.07.2011.

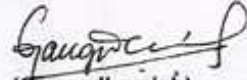
And whereas, the SRC in its 209th meeting held on 31st July 2011 considered the reply of the institution dt.28.07.2011 for the show cause notice issued, and other related documents along with the original file of the institution and decided that shifting of the institution to new/permanent premises is permitted.

Now therefore permission is hereby accorded by SRC to Sri Balaji College of Education, Sri Balaji Educational Charitable and Cultural Trust, Salem Main Road, Poondi Village, Ammaiyaaram Post, Kallakurichi Taluk, Villupuram District, Tamilnadu to shift the premises to the new location / building at Sri Balaji College of Education, S. F. No. 8/2, 8/1A, 9/13, 8/1A, 8/1D, 8/1C, 9/13A, 9/13C, 9/13E, A.Vasundenur Village, Salem Main Road, Chinna Salem, Kallakurichi Taluk, Villupuram District-606202, Tamilnadu.

If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as under the provisions of Section 17(1) of the NCTE Act.
